***The following requirements must be met in order to obtain The Hormel Foundation Austin Assurance Scholarship:***

- Received a High School Diploma from Austin Public Schools or Pacelli High School*
- Reside in the Austin Public School enrollment district*
- Students must have completed and documented 50 hours of volunteer hours*
- Meet ONE of the following requirements by the end of the first semester of the student's senior year:*
  - *Have an unweighted cumulative Grade Point Average (GPA) of 2.5 or higher*
  - *Have an ASVAB Score of 31 or Higher or have an ACT score of 18 or higher*
  - *Pass all courses with a GPA of 2.5 or Higher in their Junior & Senior Year of High School*
  - *Be a graduate of the Be Your Best College Prep Summer Academy at Riverland Community College*
  - *Qualify under Cycles for Success Selection Criteria by being in the top 75% of graduating class and meet at least one of the following categories:*
    - *Be a first generation college student (meaning that neither parent has a 4-year college degree);*
    - *Be a low-income student (for example, the family could qualify for free and reduced lunches); or*
    - *Self-identify as a member of a racial/ethnic minority*

***The following conditions are not appealable:***

- Students who have been homeschooled*
- Students residing outside the Austin Public Schools enrollment district*
- Students who have received a GED in lieu of a high school diploma*
